We are therefore committed to ensuring that Pirate Castle activities take place in as safe an environment as is possible and that we all continue to help suppress the spread of the Covid-19 virus. We will take all reasonable precautions against the Covid-19 virus and act in accordance with our Duty of Care to all concerned at all times. We will also ensure that we act in accordance with all relevant legislation and government guidance in this area. However, risk of Covid-19 transmission cannot be completely eradicated and so all participants and volunteers must sign a declaration agreeing that undertaking activities at Pirate Castle is at their own risk.

Spread of Covid-19 Coronavirus	<p>Staff, volunteers, participants and visitors to The Pirate Castle.</p> <p>Vulnerable groups – elderly, pregnant workers/participants/visitors, those with existing underlying health conditions.</p> <p>Anyone else who physically comes in contact with other people in relation to The Pirate Castle operations.</p>	<p>Hand Washing</p> <p>Hand washing facilities in each WC with soap and water in place.</p> <p>Stringent hand washing taking place and all staff/participants/visitors to be briefed and reminded to sanitise/wash hands.</p> <p>Briefings and reminders follow Government washing guidance, in particular:</p> <ul style="list-style-type: none"> when anyone arrives at The Pirate Castle at the earliest practical time after anyone blows their nose, coughs or sneezes before anyone eats or handles food hands should be washed your hands for 20 seconds, using soap and water or hand sanitiser. <p>People should also cough or sneeze into tissues before binning them – dedicated Covid-19 disposal bins will be available throughout the building and outside.</p> <p>Alcohol gel sanitisers available at all key entrances/exits throughout the building and hand washing facilities are available in all WCs. Signage placed at sanitiser stations and in WCs to remind people to wash/sanitise their hands.</p>	<p>All participants, staff, volunteers, visitors are reminded on a regular basis to wash their hands for 20 seconds with water and soap and the importance of proper drying with disposable towels available in all WCs. Also signage and reminding to catch coughs and sneezes in tissues – following Catch it, Bin it, Kill it and to avoid touching face, eyes, nose or mouth with unclean hands. Disposable tissues will be made available throughout the premises.</p> <p>To help reduce the spread of coronavirus (COVID-19) reminding everyone of the public health advice - https://www.gov.uk/government/organisations/public-health-england</p> <p>Extensive signage and information regarding precautions for managing COVID-19 on display. Guidance on regular and proper hand washing will be provided to participants.</p>	<p>Staff to ensure Covid-safe set-up of the building</p> <p>All staff, volunteers, participants and visitors to follow ongoing guidance</p>	<p>All measures in place and ongoing</p>	<p>Ongoing</p>

		<p><u>Cleaning</u></p> <p>Frequently cleaning and disinfecting objects and surfaces that are touched regularly particularly in areas of high use such as door handles, hand railings, light switches, WCs, equipment, using appropriate cleaning products and methods. A dedicated full clean at the end of each day following normal cleaning protocols.</p> <p>Cleaning protocols for use of WCs in place with all WCs in use having antiviral wipes of alternative appropriate sanitisers. All users of the WC facilities to be required to wipe down all touch points before and after use and follow hand washing protocols. Anyone using WC facilities reminded of cleaning protocols before use and asked to confirm afterwards</p> <p>All wipes, paper towels, gloves, aprons, disposable masks and any other disposable cleaning materials (including wipes in WCs) or PPE disposed of in dedicated Covid-19 bins placed throughout the building. Bins emptied and bags sealed and disposed of on a daily basis.</p> <p>Where a case of suspected Covid-19 has occurred on the premises, the affected areas to be closed to access and deep cleaned following Government guidelines for cleaning and wearing PPE.</p> <p>Guidance on cleaning after a suspected case of Covid-19 - https://www.gov.uk/government/publications/covid-19-decontamination-in-non-healthcare-settings/covid-19-decontamination-in-non-healthcare-settings</p>	<p><u>Cleaning Shared Equipment</u></p> <p>Any shared equipment sanitised with appropriate sanitiser fluid after each use. Where guidelines dictate, certain equipment stored for 72 hours after sanitisation. Where sanitiser fluid is not available all shared equipment to be wiped down with fresh water and left for 72 hours before reuse. This will include boats, paddles, buoyancy aids and any other shared objects/materials. Clean gloves to be worn whilst cleaning equipment and all paper towels, wipes used disposed of in dedicated Covid-19 bins.</p> <p>All sanitisers, soaps, paper towels, wipes and other necessary items to be regularly checked and re-stocked.</p> <p><u>Covid-19 cases</u></p> <p>If a case of suspected Covid-19 has occurred, all activities should stop, the person with the suspected case and anyone in close contact with them sent home and encouraged to follow Government / NHS advice (via 111), and the affected areas closed until after a deep clean can be performed, which will take place immediately or as soon as practically possible.</p> <p>All participants/their parents, staff, volunteers, visitors present at the time of a suspected case to be informed of the suspected case and advised to follow Government advice.</p> <p>For a confirmed case, all people who have been in close contact with the person in question must be informed. This may happen via NHS Test & Trace, however all people who had been in close contact with the suspected case to be informed by The Pirate Castle and advised follow the self-isolation Government guidance.</p> <p>A RIDDOR report to be completed after a confirmed case and submitted to the HSE - https://www.hse.gov.uk/riddor/report.htm</p>	<p>All staff, volunteers, participants and visitors to follow ongoing guidance</p>	<p>All measures in place and ongoing</p>	<p>Ongoing</p>

		<p><u>Information</u></p> <p>All staff, volunteers, participants and visitors to The Pirate Castle will receive clear information & guidance in advance of attending the premises to enable them to prepare properly to follow the new systems and protocols.</p> <p>Every staff member, volunteer, participant and visitor must complete a consent form including agreement that all Pirate Castle guidance will be followed at all times.</p>	<p>Test & Trace</p> <p>It is a legal requirement for The Pirate Castle to ensure collection of records of anyone attending the premises and keep them on record for 21 days. The Pirate Castle will supply the relevant details to NHS Test & Trace if contacted by them.</p> <p>At least one member of every party of participants or visitors must provide their name and contact details. Given this, The Pirate Castle will require the following:</p> <p>For paddlesports and canal boating, all participant attendances, dates & times and contact details are recorded on our booking system, and contact details are recorded on our Covid-19 online consent/acceptance forms which all participants are required to complete.</p> <p>For hall users, all group attendances are recorded on our booking system. The lead member of each group is also required to complete a Covid-19 online consent form including contact details. In addition to this legal requirement, every hall attendee must either scan the official NHS QR code or complete the GDPR-compliant sign in/out book.</p> <p>All other visitors, including volunteers and freelancers, must either scan the official NHS QR code or complete the GDPR-compliant sign in/out book.</p> <p>We record all staff working on the premises on a given day and retain their contact details</p> <p>All records adhere to General Data Protection Regulations</p> <p>We will refuse entry to anyone who refuses to comply with the above legal requirements.</p> <p>Full guidance - https://www.gov.uk/guidance/maintaining-records-of-staff-customers-and-visitors-to-support-nhs-test-and-trace</p> <p>All people coming to The Pirate Castle must follow guidance and protocols at all times. 		<p><u>Physical Distancing</u></p> <p>To reduce the risk of transmission, group sizes limited to government guidance and group activity staggered to avoid two groups in the same space. Within the building, all spaces marked out clearly with 2m distancing tape. Outside the building, marking in place and people encouraged to remain at 2m and where not possible or impractical (potentially on the water) people must remain at 1m+ with mitigations including not facing another person, regular hand hygiene and, where appropriate, face coverings (note below coverings on the water on the water).</p> <p>One-way systems in place throughout the premises and clearly marked with arrows and no entry signs. Clear signage in place to highlight the one-way systems and distancing requirements.</p> <p><u>Face coverings</u></p> <p>All staff, participants, volunteers and visitors must wear face coverings inside the public spaces of the building at all times. In private staff areas, 2m distancing will be in place and when not possible, face coverings should be worn when closer than 2m.</p> <p>On the water, it is impractical to wear face coverings from a health & safety perspective. Care should be taken to remain at 1m+ at all times from others, to stay facing away from others whilst closer than</p>	<p>activity and/or ask people to leave where anyone continually refuse to follow the protocols.</p> <p>Following British Canoeing guidance, participants must be able paddlers and capsized paddlers need to be able to self-rescue. Any close-up rescue puts paddlers and staff/volunteers at a higher risk of infection. The only exception will be in an emergency situation when a paddlers wellbeing is at risk.</p> <p>Participants will be expected to provide/bring their own face coverings. 		<p>2m, and follow strict hand washing guidance immediately after coming off the water.</p> <p><u>Screening</u></p> <p>Temperature checks on all staff, volunteers, participants and visitors to be taken by a staff member with a non-contact thermometer on entry to the building. Anyone with a raised temperature (37.8C or above) will not be allowed access, including their family/group they have been in close contact with, and encouraged to go home and follow Government / NHS advice (via 111).</p> <p>All staff, volunteers, participants and visitors will be instructed to not come to The Pirate Castle if they, or anyone they are or have been in close contact with, has symptoms of Covid-19 or has been told to self-isolate. Encouraged to follow Government / NHS advice (via 111).</p>	<p>Note on arrivals: All staff, participants and volunteers will be instructed to wait outside the building and keep to 2m physical distancing until let in by a member of staff. Clear signage will be on the entry door – wait to be let in, masks/coverings must be worn inside the building at all times, temperature checks taken and hand sanitiser to be used on entry.</p>	<p>All staff, volunteers, participants and visitors</p>	<p>Ongoing</p>
